

AN ORDINANCE AMENDING ORDINANCE NO. 687 ENTITLED

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS as follows:


SECTION 1. That Ordinance No. 687 entitled "AN ORDINANCE
REGULATING: THE USE OF PUBLIC AND PRIVATE SEWERS AND DRAINS, PRIVATE
WASTEWATER DISPOSAL, THE INSTALLATION AND CONNECTION OF BUILDING
SEWERS, THE DISCHARGE OF WATERS AND WASTES INTO THE PUBLIC WASTEWATER
SYSTEM, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF; THE LEVYING
OF CHARGES FOR WASTEWATER SERVICES (USE CHARGES)", be and hereby is
amended by inserting the word "useful" in place of the word "service"
in line three of paragraph 39 of Appendix #1 DEFINITIONS.

SECTION 2. This ordinance shall be in full force and effect
from and after its passage, approval and publication in pamphlet form
as provided by law.


which provided by its terms that it should be published in pamphlet form.
