

**AN ORDINANCE RELATING TO THE APPOINTMENT AND THE DUTIES OF
THE VILLAGE FIRE CHIEF**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF

THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS as follows:

SECTION 1. That the President, with the consent of the Board of Trustees, shall appoint a Village Fire Chief to hold office at the pleasure of the President and the Board of Trustees. The Village Fire Chief may be removed or dismissed without cause by the President, with the consent of the Board of Trustees of the Village, at any time after his appointment. A new appointment shall be made by the President and Board of Trustees in a timely manner.

SECTION 2. The Village Fire Chief shall enforce or cause to be enforced all ordinances of the Village and all laws of the State of Illinois.

SECTION 3. It shall be the duty of the Village Fire Chief to attend all meetings of the Board of Trustees of the Village, to serve all notices in writing when so ordered by the Village Board, and to perform all such other duties as shall be prescribed by Ordinances of said Village or by any resolution or order adopted by the Board of Trustees in said Village from time to time. He shall be the supervisor and administrator of the Fire Department, its men, and its files.

SECTION 4. The Village Fire Chief shall possess the power and authority of a Fire Chief pursuant to the statutes of the State of Illinois within the corporate limits of the Village.


SECTION 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

SECTION 6. All Ordinances and Resolutions in conflict herewith are hereby modified or repealed to the extent that the same are in conflict with this Ordinance.


