

ORDINANCE NO. 670

**AN ORDINANCE AMENDING ORDINANCE NO. 569 ENTITLED
"ORDINANCE ESTABLISHING RATE OF COMPENSATION FOR
VILLAGE FIREMEN", AS AMENDED**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS as follows:

SECTION 1. That Ordinance No. 569 entitled "Ordinance Estab-
lishing Rate of Compensation for Village Firemen", as amended, be
and the same is hereby amended by deleting Sections 2 and 4 thereof
from said Ordinance No. 569 and substituting for the same the follow-
ing:

"Section 2. In addition to the foregoing compensation,
the following compensation shall be paid:

- (A) One Thousand Five Hundred Seventy-five Dollars
(\$1,575.00) per year to the Fire Chief.
- (B) Seven Hundred Eighty-seven Dollars and Fifty
Cents (\$787.50) per year to the First Assistant
Fire Chief.
- (C) Five Hundred Twenty-five Dollars (\$525.00)
per year to the Second Assistant Fire Chief.
- (D) Four Hundred Twenty Dollars (\$420.00) per
year to the Department Secretary.

Section 4. The rates of compensation hereinabove set
forth shall be effective May 1, 1989 and shall be due
and payable November 1, 1989 and each November 1 there-
after."

SECTION 2. This ordinance shall be in full force and effect
from and after its passage, approval and publication in pamphlet form
as provided by law.

SECTION 3. All Ordinances and Resolutions in conflict here-
with are hereby modified or repealed to the extent that the same are
in conflict with this Ordinance.
