

**AN ORDINANCE AMENDING ORDINANCES NO. 357 AND 481, AS AMENDED  
TO PROVIDE FOR REDUCED SEWER USE RATES**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF  
THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS as follows:

SECTION 1. That Ordinances No. 357 and 481, as amended,  
be and hereby are amended as follows:

Section 1. That the charge for sewer use during  
the months of May through September, inclusive, of each  
year shall be computed as hereinafter set forth upon the  
request of the sewer user and said computation shall remain  
in effect throughout said months.

Section 2. The request for computation of sewer  
use charges to be computed as hereinafter set forth shall  
be filed with the Office of the Sewer and Water Department  
by the sewer user on or before May 1 of each year.

Section 3. The sewer use charge herein provided  
for shall be computed by averaging the sewer user's metered  
service for the months of October through March and immedi-  
ately preceding the period for which the sewer user applies  
for this rate and then by adding ten percent (10%) to said  
average; that the sum resulting from said computation shall  
be the monthly sewer use charge for the period of May through  
September requested by the sewer user.

Section 4. In the event any sewer user requesting  
the summer rate herein provided for does not have sufficient  
prior sewer use charges to compute a May through September  
charge as herein provided for, then such sewer user's rate  
shall be computed at the rate of \$14.30 per month for a  
family of two (2) or less plus \$7.15 per month for each  
family member in excess of two (2). The rate thus estab-  
lished shall be subject to the ten percent (10%) increase  
as set forth in Section 3 hereof.

Section 5. Any sewer user may request the summer  
rate herein provided for after May 1 provided, however,  
the rate shall be the highest of the two rates provided

for in Sections 3 and 4 hereof plus a one-time fee of Five Dollars (\$5.00) for the months concerned.


SECTION 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

SECTION 3. All Ordinances and Resolutions in conflict herewith are hereby modified or repealed to the extent that the same are in conflict with this Ordinance.

I further certify that on May 4, 1989 the corporate authorities of said Village passed and approved Ordinance No. 666 entitled:


