

AN ORDINANCE AMENDING ORDINANCE NO. 357 ENTITLED  
"AN ORDINANCE ESTABLISHING CHARGES AND RATES FOR  
THE USE AND SERVICE OF THE COMBINED WATERWORKS AND  
SEWERAGE SYSTEM OF THE VILLAGE OF SOUTH JACKSONVILLE,  
ILLINOIS" AS AMENDED BY ORDINANCE NO. 624  
AND AS AMENDED FROM TIME TO TIME

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF  
THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS as follows:


Section 1. That Ordinance No. 624 entitled "An Ordinance  
Amending Ordinance No. 357 entitled 'An Ordinance for Establishing  
Charges and Rates for the Use and Service of the Combined Waterworks  
and Sewerage System of the Village of South Jacksonville, Illinois'  
and Repealing Ordinance No. 583 for the Purpose of Establishing New  
Water and Sewer Rates" be and is hereby amended by deleting from the  
first line of "Section 1." under the heading of "Sewer Service" the  
figures "\$5.55" and inserting in place thereof the figures "\$10.55".

Section 2. This Ordinance shall be in full force and effect  
for all sewer service rendered on and after MAY 1, 1989.  
Section 3. This ordinance shall be in full force and effect  
from and after its passage, approval and publication in pamphlet form  
as provided by law.


