

ORDINANCE NO. 624

AN ORDINANCE AMENDING ORDINANCE NO. 357 ENTITLED "AN ORDINANCE FOR ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE COMBINED WATERWORKS AND SEWERAGE SYSTEM OF THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS" AND REPEALING ORDINANCE NO. 583 FOR THE PURPOSE OF ESTABLISHING NEW WATER AND SEWER RATES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS:

SECTION 1. That Ordinance No. 583 entitled "An Ordinance Amending Ordinance No. 357 entitled 'An Ordinance for establishing charges and rates for the use and service of the combined waterworks and sewerage system of the Village of South Jacksonville, Illinois' for the Purpose of Establishing New Water and Sewer Rates" be and the same is hereby repealed.

SECTION 2. That Ordinance No. 357 entitled "An Ordinance for establishing charges and rates for the use and service of the combined waterworks and sewerage system of the Village of South Jacksonville, Illinois", and all amendments thereto in conflict with this amendment, be and they are hereby amended by deleting Section 1 thereof from said Ordinance No. 357 and substituting for the same the following:

"Section 1. That there shall be and there are hereby established rates and charges for the use of and for the services supplied by the combined waterworks and sewerage system of the Village as follows:

RATES - PREMISES SERVED BY BOTH WATER AND SEWER

For those premises which are served by both water and sewer service of the Village of South Jacksonville, Illinois, the rates for the water service and the rates for the sewer service shall be as follows:

0 - 2,000 Gal.	\$ 5.00
2,001 - 5,000 Gal.	5.00 + .00187 per gal. over 2,001
5,001 - 10,000 Gal.	10.61 + .00162 per gal. over 5,001
10,001 - 20,000 Gal.	18.71 + .00155 per gal. over 10,001
20,001 - 30,000 Gal.	34.21 + .00139 per gal. over 20,001
30,001 - 50,000 Gal.	48.11 + .00123 per gal. over 30,001
50,001 - 100,000 Gal.	72.71 + .00108 per gal. over 50,001
100,001 - Over	126.71 + .00093 per gal. over 100,001

<u>Sewer Service</u>	
0 - 2,000 Gal.	\$ 5.55
2,001 - 5,000 Gal.	5.55 + .00125 per gal. over 2,001
5,001 - 10,000 Gal.	9.30 + .00125 per gal. over 5,001
10,001 - 20,000 Gal.	15.55 + .00125 per gal. over 10,001
20,001 - 30,000 Gal.	28.05 + .00125 per gal. over 20,001
30,001 - 50,000 Gal.	40.55 + .00125 per gal. over 30,001
50,001 - 100,000 Gal.	65.55 + .00125 per gal. over 50,001
100,001 - Over	128.05 + .00125 per gal. over 100,001

RATES - PREMISES SERVED BY WATER ONLY

For those premises which are served by water service only of the Village of South Jacksonville, Illinois, the rates for the water service shall be as follows:

0 -	2,000 Gal.	\$ 5.35	
2,001 -	5,000 Gal.	5.35 + .00200	per gal. over 2,001
5,001 -	20,000 Gal.	11.35 + .00175	per gal. over 5,001
20,001 -	30,000 Gal.	37.60 + .00149	per gal. over 20,001
30,001 -	50,000 Gal.	52.50 + .00132	per gal. over 30,001
50,001 -	100,000 Gal.	78.90 + .00118	per gal. over 50,001
100,001 -	Over	137.90 + .00102	per gal. over 100,001

RATES - PREMISES SERVED BY SEWER ONLY

For Residences: A flat charge of \$10.00 per month per residence.
Others: A flat charge per month to be set by the Village for each connection based upon the estimated volume of sewerage involved, but in no case, less than \$10.00 per month per connection.

CONNECTION CHARGES

For Water and Sewer Combined: \$100.00
For Sewer Only: \$100.00
For Water Only: \$100.00 "

SECTION 3. The purpose of the rate increases hereinabove set forth is to fund expenses required to be incurred by the Village of South Jacksonville, Illinois, in order to carry out certain water and sewer improvements mandated for the most part by the Illinois and Federal Environmental Protection Agencies and to the extent that the same should prove not to be necessary for funding the aforesaid expenses, it is the intention of the Board of Trustees that said rates will be reduced accordingly.

SECTION 4. This Ordinance shall be in full force and effect for all water purchased on and after December 1, 1985.
