

ORDINANCE NO. 498

AN ORDINANCE TRANSFERRING CERTAIN APPROPRIATIONS WITHIN  
MUNICIPAL DEPARTMENTS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE  
OF SOUTH JACKSONVILLE, ILLINOIS:

Section 1. That the funds appropriated for "Title II Anti-Recession Department" by Ordinance No. 491 whereby certain appropriations were made for the fiscal year commencing with the third Tuesday in April, 197~~8~~<sup>7</sup>, identified as Item 422 for the purpose of repairs in the amount of One Thousand Eighty-one and 88/100 Dollars (\$1,081.88) be and hereby is transferred to Account 400 of the same Department for the purpose of salaries.

Section 2. That the funds appropriated for "Fire Department" by the aforesaid Appropriation Ordinance identified as Item 701 for the purpose of Salaries - Village Officials (NT) in the amount of Three Thousand Dollars (\$3,000.00) be and hereby is transferred to Account 747 of the same Department for the purpose of meetings and travel.

Section 3. That the funds appropriated for "Rescue Unit" by the aforesaid Appropriation Ordinance identified as Item 801 for the purpose of Salaries - Village Officials (NT) in the amount of One Thousand Five Hundred Dollars (\$1,500.00) be and hereby is transferred to Account 847 of the same Department for the purpose of meetings and travel.

Section 4. That Four Hundred Dollars (\$400.00) of the funds appropriated for "Revenue Sharing Department" by the aforesaid Appropriation Ordinance identified as Item 105 for the purpose of capital improvements be and hereby is transferred to Account 434 of the same Department for the purpose of public benefits.

Section 5. That this Ordinance shall be in full force and effect from and after its passage, approval and recording as provided by Ordinance and law.

Section 6. That all ordinances and resolutions in conflict herewith are hereby modified or repealed to the extent that the same are in conflict with this Ordinance.
