

ORDINANCE NO. 461

AN ORDINANCE PROVIDING FOR THE APPROPRIATION OF CERTAIN AMOUNTS FOR CERTAIN CORPORATE PURPOSES OF THE VILLAGE OF SOUTH JACKSONVILLE, MORGAN COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING WITH THE THIRD TUESDAY IN APRIL, 1975, AND ENDING WITH THE MONDAY PRECEDING THE THIRD TUESDAY IN APRIL, 1976.

BE IT ORDAINED, by the President and Board of Trustees of the Village of South Jacksonville, Morgan County, Illinois, that there be, and there hereby is appropriated for the fiscal year beginning with the Third Tuesday in April, 1975, and ending with the Monday last preceding the Third Tuesday in April, 1976, the sum of Four Hundred Forty Thousand Two Hundred Dollars (\$440,200.00) for the purposes and amounts hereinafter set forth, to-wit:

notice, the same to be served as hereinabove set forth, directing the foregoing persons to secure a licensed plumber and complete the repair.

In the event of the failure of the foregoing persons or any of them to complete the repair as aforesaid, the Village of South Jacksonville shall complete the same and the foregoing persons or any of them shall pay all charges for the same upon rendering of a bill for the same by the licensed plumber secured by the Village of South Jacksonville to complete the repair.

Section 3-D. In the event the charges for repairs payable by the the owner of the premises, the occupant thereof and the user thereof as aforesaid are not paid within thirty (30) days of receipt of the bill for the same, the Village of South Jacksonville shall have the same rights and duties with regard to collection of the same, as provided in Sections 5 and 6 of this ordinance for the collection and payment of sewer and water rates and charges.
