

ORDINANCE NO. 456 A

AN ORDINANCE CREATING A PARKS BOARD FOR THE PURPOSE  
OF ADMINISTERING THE OPERATIONS OF THE PARKS OF THE  
VILLAGE OF SOUTH JACKSONVILLE, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE  
OF SOUTH JACKSONVILLE, ILLINOIS:

Section 1. There is hereby established a South Jacksonville, Illinois  
Parks Board.

Section 2. Said Board shall consist of five (5) persons serving  
without pay who shall be appointed by the President of the Board of Trustees  
subject to the approval of said appointees by the Board of Trustees.

Section 3. The term of office shall be for five (5) years or until  
their successors are appointed and qualified, except that the members of such  
Board first appointed shall be appointed for such terms that the term of one  
member shall expire annually thereafter. Vacancies in such Board occurring  
otherwise than by expiration of term shall be filled by appointment by the President  
of the Board of Trustees with the approval of the Board of Trustees for the  
unexpired term.

Section 4. Said Board shall be responsible for all policies, rules  
and regulations relating to the management of the parks of the Village of South  
Jacksonville, Illinois and the administration of a public recreation program.

Section 5. Immediately after the Board's appointment it shall  
meet and organize by electing one of its members President and by installing  
such other officers as may be necessary. The Board shall have the power to  
adopt By-Laws, rules and regulations for the proper conduct of its affairs.

Section 6. The Board shall provide, conduct and supervise public  
playgrounds, athletic fields, recreation centers and other recreation facilities  
and activities on any of the properties owned or controlled by the Village or on  
other properties with the consent of the owners and authorities thereof. It shall  
have the power to conduct any form of recreation activity that will employ the  
leisure time of the people in a constructive and wholesome manner.

Section 7. The Board shall submit annually a budget to the Board of Trustees for its approval and funding.

Section 8. The Board may solicit or receive any gifts or bequests of money or other personal property or any donations to be applied, principal or income, for either temporary or permanent use for playgrounds or other recreational purposes.

Section 9. The Board shall make a full and complete annual report to the Board of Trustees setting forth the activities and expenditures and income of the Board during the previous year.
