

ORDINANCE NO. 277

AN ORDINANCE PROVIDING FOR THE ANNUAL TAX
LEVY FOR THE FISCAL YEAR COMMENCING THE
THIRD TUESDAY IN APRIL, 1959, AND ENDING WITH
THE MONDAY LAST PRECEDING THE THIRD TUESDAY
IN APRIL, 1960.

WHEREAS, the President and Board of Trustees of the Village of South Jacksonville, in the County of Morgan, State of Illinois, did on the eighteenth day of June, 1959 pass the annual appropriation bill for said Village of South Jacksonville for the fiscal year beginning on the third Tuesday in April, 1959 and ending with the Monday last preceding the third Tuesday in April, 1960, and

WHEREAS, said appropriation bill was duly published in the first quarter of the fiscal year of said Village to-wit: On June 19, 1959 in the Jacksonville Courier, a newspaper of general circulation in said Village, there being no newspaper published in said Village, and

WHEREAS, the annual appropriation ordinance provides for a total appropriation in the amount of \$97, 875. 00 for the fiscal year beginning on the third Tuesday in April, 1959 and ending with the Monday last preceding the third Tuesday in April, 1960.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of South Jacksonville:

Section One. That there be and hereby is levied upon all the taxable property within the corporate limits of said Village for the fiscal year beginning with the third Tuesday in April, 1959 and ending with the Monday last preceding the third Tuesday in April, 1960 the total sum of \$15,250.00 for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows to-wit:

Section Two. That there be, and there hereby is, levied upon all the taxable property within the corporate limits of the Village of South Jacksonville, Illinois subject to taxation for the year 1959, pursuant to the authorization of Article 39, Chapter 24, Revised Statutes of Illinois, heretofore adopted at a special election duly and regularly held on November 7, 1950 the total sum of \$1500.00 for the following specific purposes mentioned in said appropriation bill and in the sum as follows:

Section Three. That there be, and there hereby is, levied upon all the taxable property within the corporate limits of the Village of South Jacksonville, Illinois subject to taxation for the year 1959 pursuant to the authorization of Article 40, Chapter 24, Revised Statutes of Illinois, the total sum of \$2000.00 for the following specific purpose mentioned in said appropriation bill and in the sum as follows:

Section Four. That there be, and there hereby is, levied upon all the taxable property within the corporate limits of the Village of South Jacksonville, Illinois subject to taxation for the year 1959, pursuant to the authorization of Article 84, Paragraph 33-B, Chapter 24, Revised Statutes of Illinois, the total sum of \$500.00 for the following specific purpose mentioned in the appropriation bill and in the sum as follows:

Section Five. That there be, and there hereby is, levied upon all the taxable property within the corporate limits of the Village of South Jacksonville, Illinois subject to taxation for the year 1959, pursuant to the authorization of Section 281 of Chapter 127, Revised Statutes of the State of Illinois, the total sum of \$100.00 for the following specific purposes mentioned in the appropriation bill in the sum as follows:

Section Six. The Village Clerk of said Village of South Jacksonville is hereby directed to file with the County Clerk of Morgan County a duly certified copy of this ordinance.

Section Seven. This ordinance ^{to} ~~should~~ take effect ^{and be} in full force and effect from and after its passage and approval.
